

RESOLUTION NO. 2021-61R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CELINA, TEXAS, TO TAKE A RECORD VOTE TO PLACE A PROPOSAL FOR ADOPTION OF THE FISCAL YEAR 2021-2022 BUDGET AND TAX RATE ON THE AUGUST 10, 2021 AGENDA; SPECIFYING THE PROPOSED PROPERTY TAX RATE; ESTABLISHING DATES FOR PUBLIC HEARINGS ON THE PROPOSED PROPERTY TAX RATE; AND PROVIDING FOR THE PUBLICATION AS PROVIDED BY THE TEXAS PROPERTY TAX CODE.

WHEREAS, the City of Celina has received the calculated effective tax rate information as presented by the Collin County Tax Assessor/Collector's Office; and

WHEREAS, the proposed tax rate of \$0.645000 exceeds the no-new-revenue effective tax rate of \$0.586330 and does not exceed the voter-approval rollback tax rate of \$0.645000. Statute requires one public hearing in order to entitle the City Council to consider acceptance and adoption of an ordinance levying a proposed tax rate; and

WHEREAS, the Texas Property Tax Code Chapter 26, as heretofore amended, provides the specific procedures in which to consider the proposed tax rate;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CELINA, TEXAS

SECTION 1. The City of Celina placed a proposal for adoption of the budget and tax rate for fiscal year 2021-2022 on the agenda for the September 14, 2021 Council meeting.

SECTION 2. Public Hearing on the proposed tax rate shall be held on September 14, 2021 at 5:00 p.m. in the Celina City Council Chambers at 112 N. Colorado, Celina, Texas 75009 to receive public comment.

SECTION 3. Public Hearing on the proposed budget shall be held on September 14, 2021 at 5:00 p.m. in the Celina City Council Chambers at 112 N. Colorado, Celina, Texas 75009 to receive public comment.

SECTION 4. The City Council of the City of Celina, Texas met in a public meeting on August 10, 2021, and accepted this resolution with a majority vote as follows:
